## TOWN OF SOUTH HADLEY NOTICE OF PLANNING BOARD PUBLIC HEARING Relative to a Proposed Zoning By-Law Amendment

Pursuant to the provisions of the South Hadley General By-Law and M.G.L. Chapter 40A, Section 5, the Planning Board of the Town of South Hadley will hold a public hearing to discuss proposed amendments to the South Hadley Zoning By-Law and General By-Law as noted herein. The public hearing will be held as follows:

The subject matter of the proposed amendments to the Zoning By-Law is as follows:

1. To see if the Town will vote to amend the Zoning By-Law in regard to agricultural, horticultural, and floricultural uses (particularly in regards to keeping of poultry) in residential zoning districts by amending: Section 7, **SUPPLEMENTAL DISTRICT REGULATIONS**, Subpart (D) **Agricultural, Horticultural, and Floricultural Uses**, by removing such language as prohibits keeping of poultry in the Residence A-1 zoning district or in any other way being more restrictive in the Residence A-1 zoning district than in other residential zoning district in regard to the provisions of this particular subpart (D) of Section 7 of the Zoning Bylaw or take any other action thereto..
